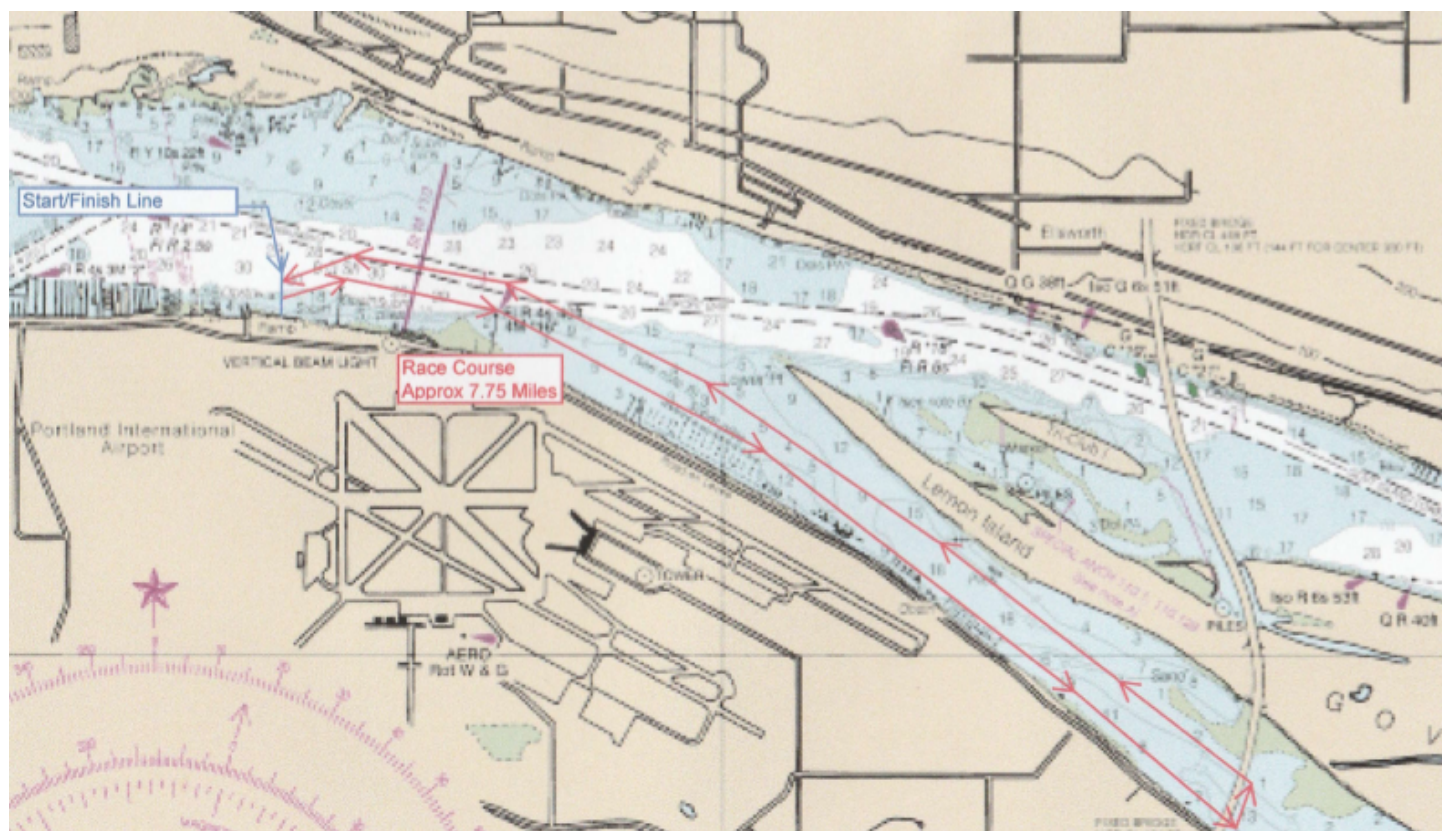

- Safety boats will be on the course to offer assistance, but are not responsible for paddlers or equipment. PNW-ORCA Race rules apply www.pnworca.org/racing/officialrules/.
- The race director reserves the right to combine or eliminate categories that do not have enough competitors.
- The Columbia River is a popular recreational boating area and motor boat traffic may be heavy at times. There is also commercial shipping traffic that has the right of way. There are wing dams off shore and strong currents.
- The race director reserves the right to change the course due to conditions (e.g. weather, boating traffic, water conditions) that may pose a threat to participants.

Directions:

From Points North:

- Follow I-5 S to OR-99E S/NE Martin Luther King Jr Blvd in Portland. Take exit 307 from I-5 S
- Drive to N Marine Way
- Keep right at the fork, follow signs for I-5/Marine Dr E
- Turn right onto N Union Ct
- Continue onto N Marine Way

From Points South:

- Take exit 307 from I-5 N toward Marine Drive E
- Keep right at the fork, follow signs for I-5/Marine Dr E
- Turn right onto N Union Ct
- Continue onto N Marine Way
